Early this spring the Iowa Job Connection Program (JCEP) began working with Command Sergeant Major John Breitsprecker; the Iowa National Guard's Senior Enlisted Advisor on engaging our Soldiers assigned to the Warrior Transition Units (WTU)'s. While out visiting soldiers CSM Breitsprecker found several Soldiers at the WTU's who needed assistance with employment when returning home to Iowa and the Iowa National Guard. SGT Justin Stewart always wanted to go in to Law Enforcement. He attended Liberty University and Des Moines Community College pursuing an Associate's degree in Criminal Justice prior to his deployments. Now he may be able to make his goal reality; a position in Law Enforcement. SGT Stewart and JCEP started working together in March, first building him a resume he could use when he came home to Iowa. After seven months being assigned to the WTU, Sergeant Justin Stewart was released from the WTU returning to Iowa and beginning his employment search.

In April, Justin and JCEP attended the Des Moines Area Community College's (DMACC) Iowa Veterans Career Retreat; he attended many of the Veteran transition sessions networking throughout the day. After considering many different options, Justin applied for a Security Officer position at Des Moines Area

Community College in May; in the beginning of June he started his new position as a DMACC Security Officer. Sergeant Justin Stewart now has the opportunity to gain valuable experience while he continues working toward his Associates degree in Criminal Justice. From his deployments, being assigned to the WTU, to now becoming a Security Officer, he is now one step closer to his goal of a career in Law Enforcement. Congratulations Justin!!!!!
